By Train


Prague is an important railroad junction and can be comfortably reached by train from all major European cities. The railway station is within very close walking distance of the city centre.

By Road

Arriving to Prague by car is easy. Listed below are distances from some nearby cities: Vienna 280 km, Bratislava (Slovakia) 341 km, Berlin 348 km, Frankfurt 364 km, Munich 382 km, Zurich 690 km.

By Air

Vaclav Havel Airport Prague is situated to the northwest of the city, with connections with the city centre (reachable within 20 minutes with good traffic), by taxi or by bus. Bus line 119 takes its passengers to the closest subway station; the city centre is reachable within minutes from there. Regular transportation prices are 24 CZK (0.93 EUR) for 30-minute ticket. Tickets can be purchased at the airport. A shuttle service to the airport can be booked with the hotel for EUR 28.



Jim Kleiger, Psy.D, ABPP, ABAP is in private practice in Bethesda, Maryland. A Fellow in the Society for Personality Assessment and Past President of the Baltimore Washington Psychoanalytic Society, Jim is a novelist and author of three books on the Rorschach assessment of psychosis and disordered thinking.
